Auckland DHB

Pat Snedden, Chair

Mr Snedden has extensive governance experience, having served as Chair of Auckland and Counties Manukau DHBs, The Big Idea Charitable Trust, National Science Challenge - E Tipu E Rea and Ko Awatea Health Paternership, amongst others. He is a former Director of the Ports of Auckland and Te Urungi o Ngati Kuri Ltd and was Chief Crown Negotiator in the Office of Treaty Settlements from 2008-13. He is currently Executive Chair of the Manaiakalani Education Trust, which works in the service of challenged school communities in Tāmaki.
