I cannot generally provide information about the dates on which I consider or issue intelligence warrants, for reasons of national security. After the unprecedented attacks of 15 March, however, it was appropriate to let the public know that my response, and the response of the agencies, had included the issuing of intelligence warrants. Given that this information is already in the public domain, I have included the relevant dates in this release of my diary information. Disclosure of the dates on which warrants are considered or issued will not be my practice in the future.
