### **2019 Conservation Boards Appointments**

#### **Te Hiku Conservation Board**

Two appointments to the Te Hiku Conservation Board.

**Appointment: Mr Gideon PORTER of Kaitaia.** Mr Porter has been a journalist for over 20 years, covering local politics and Māori issues, and is active in caring for Te Oneroa A Tohe (90 Mile Beach). He has iwi affiliations to Te Rarawa and Ngāpuhi.

Appointment: Ms Waikarere GREGORY of Kaitaia. Ms Gregory is nominated by Te Rūnanga o Te Rarawa. She is involved in the general activities of her marae Te Rarawa, and in recent years has also helped organise Wananga, hui, and projects to reconnect people and offer opportunities to grow and move forward. She has a great passion for the arts and leads workshops on storytelling and kaupapa Māori.

#### **Northland Conservation Board**

One reappointment and one new appointment to the Northland Conservation Board.

Reappointment: Ms Tania MCINNES of Paihia. Ms McInnes is the current deputy mayor of the Far North District Council. She is involved with many community initiatives, including been a founding member of Focus Paihia Charitable Community Trust. Tania also has a background in tourism, hospitality and project management, and a strong understanding of public process and Māori protocols.

**Appointment: Ms Georgina O'CONNOR of Mangawhai.** Ms O'Connor holds a bachelor of Māori Development and currently studying towards a Post Graduate Diploma in Public Health. She is currently employed as an environmental scientist and project co-ordinator for Wiley Geotechnical Ltd. She has iwi affiliations to Ngāpuhi and Te Mahurehure.

#### **Auckland Conservation Board**

One reappointment and four new appointments to the Auckland Conservation Board.

**Reappointment: Dr Andrew JEFFS of Auckland.** Dr Jeffs is a marine scientist at the University of Auckland and managing director of Two Fathom Ltd. He has broad scientific, environmental and business knowledge, as well as a prior knowledge of the Department of Conservation's work and functioning. He holds a PhD in Marine Science and a Post Graduate Diploma in Commerce.

She has eight years' experience as a senior manager at Auckland Zoo and is a former board member of GirlGuiding New Zealand.

**Appointment: Mr Pengbo JIANG of Auckland.** Mr Jiang is an experienced board member and advisor in public and not-for-profit sectors. He holds a Master's degree in Management and has a Certificate in Māori Studies. With a background in volunteering he is a recipient of the Sovereign's Medal for Volunteers in recognition of work in the community.

#### **Waikato Conservation Board**

One reappointment and two new appointments to the Waikato Conservation Board.

Reappointment: Mrs Melissa KING-HOWELL of Hamilton. Mrs King-Howell has experience as an Area Manager for Department of Conservation in the Hauraki-Waikato area and led the Māori Focused Unit with the Waikato Regional Council. She has skills in business, land and environment management, has extensive Māori networks and holds a range of trustee roles in the Not for Profit Sector. Melissa currently runs her own company specialising in service design and delivery through collaborative leadership. Her tribal affiliations are Ngaati Maahanga, Ngaati Te Wehi and Tuuhourangi.

**Appointment: Mrs Flora BARTHOLOMEW of Te Kuiti.** Mrs Bartholomew is a self-employed dairy farmer and holds a Certificate in Biology, a Bachelor in Horticultural Science and a Diploma in Business Management. She has five QEII blocks on her property and is a member of Rural Women NZ, Federated Farmers and Dairy Women's Network.

Appointment: Ms Gaylene ROBERTS of Putaruru. Ms Roberts is of Ngati Raukawa and Waikato Tainui descent nominated by the head of Kahui Ariki (the Maori Sovereign, King Tuheitia). She is on the Board in terms of the Waikato Raupatu Lands Settlement Act 1995. She has strong governance experience and is currently a chairperson and member on several boards and trusts, such as the Raukawa Settlement Trust, Waipa District Council Iwi Consultative Committee and Waikato District Health Board Kaunihera Kaumātua. She has previously been on the Board from 2012-2013, also nominated by the head of Kahui Ariki.

#### **Bay of Plenty Conservation Board**

Three reappointments and one new appointment to the Bay of Plenty Conservation Board.

**Reappointment:** Mr Mark COPELAND of Rotorua. Mr Copeland has over 25 years legal experience, including in resource management, property and conservation. He is also a governance consultant and expert rural mediator. He has enjoyed a lifetime interest in the New Zealand outdoors.

**Reappointment: Mrs Anne MACKERSEY of Tauranga.** Mrs Mackersey is a farm manager in Whakamarama. She has trained in landscape architecture and has a lifelong interest in land management and environmental practices. She is an active member on several local community groups.

RMA consultant and manager of the Environmental Unit at the Ngāti Rangiwewehi Charitable Trust. She holds a Master's degree with a double major in Environmental Planning, and Earth Sciences. She has affiliations to Ngāti Rangiwewhi, Te Whānauā-Apanui, NgāiTai, Te Whakatōhea and Te Arawa.

# East Coast / Hawke's Bay Conservation Board

Two reappointments and one new appointment to the East Coast/ Hawke's Bay Conservation Board.

**Reappointment:** Dr Lucy MEAGHER of Hastings. Dr Meagher is a science teacher with past employment as a research scientist for Fonterra and AgResearch. She has a PhD in Agricultural Chemistry and is a current volunteer for Forest and Bird.

He has affiliations to Ngāti Pāhauwera, YMP Rugby, Ngai Te Aonui, Te Whanau O Rongomaiwahine and supports Mahia and Wairoa Ross Shield Rugby.

## **Tongariro / Taupo Conservation Board**

Three new appointments to the Tongariro/ Taupo Conservation Board.

Appointment: Mrs Amoa HAWIRA of Raetihi. Mrs Hawira is currently studying towards a Undergraduate Degree in Environmental Management and has a strong community and cultural presence in the rohe. #### Taranaki / Whanganui Conservation Board

She has a strong legal background in Māori land, Treaty of Waitangi, corporate governance and public law. Also has governance and prior conservation board experience, and strong iwi, hapū and marae networks in Taranaki and Whanganui.

**Appointment: Mr Andrew (Drew) CASTLE of Inglewood.** Mr Castle is a self-employed IT professional. He has a good understanding of the pressure on native species and how IT can support conservation initiatives. He currently volunteers for the Taranaki Kiwi Trust and also monitors a trap line on his property.

**Appointment: Mr Robert (Boy) CRIBB of Whanganui.** Mr Cribb is nominated by the Ngā Tāngata Tiaki o Whanganui Trust. Has strong governance experience and is currently chair and member on several boards/trusts.

**Appointment: Mr Allen JUFFERMANS of New Plymouth.** Mr Juffermans is an active volunteer and business owner. He has local land and community knowledge and experience in project management, strategy, resource management planning and technical advice. He is currently a member of the NZ Institute of Surveyors, Consulting Surveyors of NZ and Resource Management Law Association.

# **Wellington Conservation Board**

Two reappointments and two new appointments to the Wellington Conservation Board.

## **Nelson / Marlborough Conservation Board**
