

## **Purpose**

- > This documents provides you with an approach to help you get to know Customs.

- It provides you with:
  - a suggested approach to learning about Customs through your regular meetings with Customs Officials
  - a list of specific additional briefings we will provide you relating to matters of immediate interest
  - suggested visits to learn more about specific parts of Customs' business
  - an outline of key briefings and activities we expect will require your attention from July to December 2019 (noting this is subject to change during the year).
- We will support you on a regular basis with:
  - regular meetings at your convenience with the Acting Comptroller and senior managers
  - weekly Ministerial report
  - briefings on specific activity.

## Proposed approach to getting to know Customs

### Initial weekly meetings with Officials

- Customs Officials will meet with you regularly.
- Option to work through parts of the business at each meeting, along with topical matters e.g.
  - Week 1: introduction to the Acting Comptroller, Customs Executive Board, Customs Strategy and key matters
  - Weeks 2 5: each week discuss how Customs' current Ministerial priorities support government priorities
    - Reducing the harm to families through increased disruption to the supply of illicit drugs into New Zealand
    - Strengthening New Zealand's trading links to support exporters
    - Eliminating the gender pay gap, paying the Living Wage and increasing diversity in Customs' workforce
    - The co-design of future border systems
  - Week 6: Customs' organisational health and key investments

### Introductory briefings

 We will provide you with specific briefings on key matters that require your attention in the short-term, support your weekly meeting with Officials, and inform any visits you do.

#### Getting to know Customs out and about

- We have outlined places to visit to help you see and hear about the work of Customs.
- We can work with your office to co-ordinate visits as part of your other Ministerial work.

 We have provided you with a high level summary of matters that may require your attention or you may wish to engage in with Customs.

#### **Events and Media**


