# PRIME MINISTER'S SUMMIT ON EMPLOYMENT: MAINTAINING THE MOMENTUM: IDEAS FOR LONGER TERM DEVELOPMENT AND CONSIDERATION

# **Proposal**

This paper describes in more detail ideas generated at the Prime Minister's Employment Summit listed for "longer term development and consideration". The paper seeks agreement to designating a lead Minister/Ministers for each idea.

# **Background**

- At is meeting on 9 March 2009, Cabinet considered a paper on maintaining the momentum from the Employment Summit [CAB Min (09) 8/6 refers]. The paper set up a number of subsequent reports to the Cabinet Strategy Committee (STR) to advance the various ideas generated at the Summit:
  - a paper for STR on 23 March covering ideas listed in the longer term for development and consideration i.e. ideas that look promising but need further exploration;
  - a paper for STR on 6 April pulling together a package of proposals worth pursuing, setting out what needs to happen next for those initiatives that are to be progressed, by whom, and over what timeframe;
  - a paper for STR on 11 May covering those ideas from the much longer list of "further investigation required" which should be taken further.
- This paper provides the first of these reports, i.e. on ideas listed in the longer term for development and consideration.

#### Comment

The Summit identified some 40 ideas as being longer term for development and consideration, spread across the six themes of the Summit: core workplace and employment issues; workers — skills and transition; local and regional government/Maori economy; helping firms survive; business investment; and firm funding.

- The ideas are set out below. This is a list rather than a prioritised package as Ministers have still to consider which ideas from the Summit the government will announce and implement now, which ideas will be worked up further to the point where Ministers can make policy and/or funding decisions, and which ideas will not be developed further at this stage but kept in mind should conditions change. Ministers will be considering placement of ideas over the next few weeks so that implementation decisions can be advanced by STR on 6 April.
- To ensure that clear lines of responsibility are established for all of the ideas, however, it would be desirable to clarify a lead Minister or Ministers for each idea. This will also help to ensure that the appropriate connection is made between Ministers and the ongoing work of the summit chairs, other stakeholders and officials.
- The Government is fortunate that there has been, and remains, a very strong commitment from the private sector to assist the Government. While not all of the ideas from the Summit will be implemented, it will be important to ensure that this input is maintained and utilised so that the most prospective ideas can be taken forward.
- Accordingly, the list below proposes a lead Minister/Ministers for each of the ideas initially grouped by the Summit as for longer term development and consideration. It is envisaged that lead Ministers will ensure that appropriate connections are made with private sector leads on specific issues.

#### Consultation

Departments with lead responsibility for the themes of the Summit have been consulted in the preparation of this paper, i.e. Economic Development, Education, Inland Revenue, Internal Affairs, Labour, Prime Minister and Cabinet, Social Development, Te Puni Kokiri and Treasury. Where possible, other departments have also been involved.

## **Fiscal Implications**

The decision to designate a lead Minister/Ministers for ideas from the summit has no fiscal implications.
